Results from Stop Data Analysis Study

April, 2017



Data that was Collected

- •Traffic Stop data was used for a 3 year period 2013-2015 at 20 locations around the city.
- •The race/ethnicity of drivers at those same locations was determined by surveying on randomly selected days and times.
- •We compared the proportion of minority stops to minority traffic.

Post Stop Data

- In addition the proportion of minority motorists searched was compared to the proportion of minority motorists stopped.
- Further, the "Hit Rate" by race/ethnicity for searches was determined.

Results

Black motorists are stopped at a higher rate than would be expected by their presence in traffic. For 2013-2014 Black Motorists are 1.85 times more likely to be stopped than expected.

For 2015, Black Motorists are twice as likely to be stopped than expected.

Post Stop Results

- Black motorists are searched far more than their presence among motorists stopped.
- Black motorists are no more likely to be carrying contraband when searched than are non-Black motorists.

Hispanic Motorists-2015

- The overall odds ratio for stopping Hispanic motorists was 1.3.
- At 5 locations Hispanics were over stopped and GRPD should monitor those locations.
- Hispanic motorists were searched at about the rate they are stopped.
- Hispanic motorists were carrying contraband at somewhat lower rate than White and Black motorists.

RECOMMENDATIONS

- GRPD should:
- Immediately Analyze 2016 Stop Data
- Annually report Stop Data & Analysis
- Review relevant policies & procedures to see whether they contribute to over stopping of Black Motorists.
- Review Data Collection to assure relevant data is recorded.

Recommendations-Con't

- Assess & evaluate all training related to bias free policing.
- Assess & evaluate its staff reward and promotion policies.
- Assess & evaluate its Field Training Officers (FTOs)
- Assess & evaluate FTO Program.

Recommendations-Con't

- Assess its Early Warning System to determine which officers/units are contributing to the over stopping/searching minorities.
- Conduct community engagement sessions.
 Purpose- discuss this report and strategy for moving forward in partnership.
- Initiate regular community feedback surveys.
- Within six months inform the community about which of these recommendations they plan to follow.
